Heard Mr.S.L.Sudarsanam, learned counsel for the petitioners and Mr.V.Jayaprakash Narayanan, learned Government Pleader (i/c.), who takes notice on behalf of the respondents.

2.According to the petitioners, they are in possession of property in Survey No.125/6B (141/1) of Gopalapuram Village, Survey No.140/57 (140/56), of Veppilaikutti Village and Survey No.140/59, of Veppilaikutti Village, respectively in Rasipuram Taluk, Namakkal District. In relation to the said properties, the petitioners have preferred appeals on 09.07.2019 to the second respondent, Sub Collector, Namakkal Division, Namakkal, under Section 10 of the Tamil Nadu Land Encroachment Act, 1905. The prayer of the petitioners is that the said appeals be disposed of at the earliest.

3.In view of the prayer of the petitioners, the appeals be disposed of by respondent no.2 as expeditiously as possible. With this observation, the writ petition is disposed of. No costs. Consequently, W.M.P.Nos.21634, 21642 and 21644 of 2019 are closed.
