2. Heard the learned counsel for the petitioners and the learned Additional Public Prosecutor appearing for the 1st respondent.

3. It is seen from records that there is a case in counter and the respondent police is investigating both the cases in Crime No.477 of 2019. Therefore, one FIR cannot be questioned at this stage and the investigation has to be conducted in both FIR's.

4. The contentions put forward by the learned counsel appearing on behalf of the petitioners are purely factual in nature and this Court cannot venture into conducting a mini investigation into the matter and it therefore does not fall within the ambit of its jurisdiction under Section 482 of Cr.P.C. Any finding on facts will also have a bearing on the investigation conducted by the respondent Police.

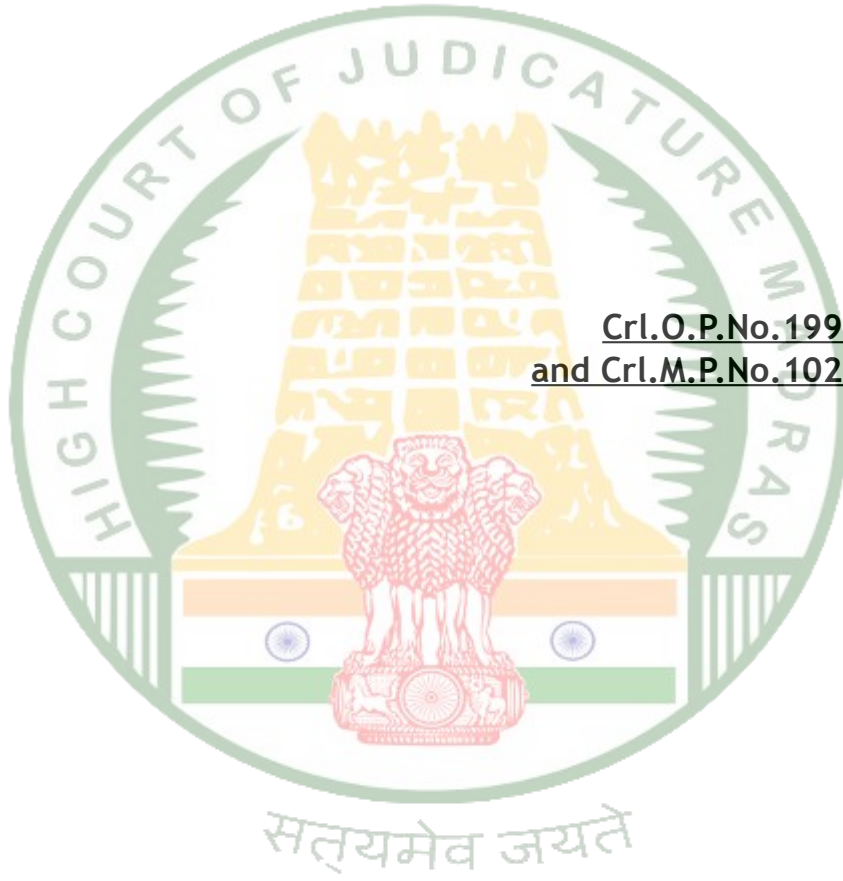
