In Crl.MP.Nos.6068 & 6070 of 2017 in Crl.R.C.No.657 of 2017, on 26.04.2017, this Court suspended the sentence and released the petitioner on bail on certain conditions, one of which, is that the petitioner shall appear before the trial Court on the first working day of every month at 10.30 a.m.

2. The present Criminal Miscellaneous Petition has been filed for modifying the above said condition on the ground that the petitioner is a cleaner in the lorry and is required to go to various places outside the State.

3. In the opinion of this Court, the aforesaid condition cannot be completely relaxed because the petitioner should be available at the time of final disposal of the revision petition. Hence, this Criminal Miscellaneous Petition is closed by granting liberty to the

petitioner to file an application under Section 317 Cr.P.C. and shall appear before the trial Court on any other day in lieu of the date of his absence, as directed by the trial Court.
