O R D E R

This petition has been filed seeking for a direction to the Court below to reschedule the dates fixed for trial in SC No.77 of 2018.

The learned counsel for the petitioner submitted that ***the same counsel has been engaged as a legal Aid Counsel for doing on important case before the Special Court, Chennai** for which, the dates have ***already** been fixed every week from Tuesday to Friday and therefore, she is not in a position to conduct the trial daily ***basis** before the learned District Mahila and Sessions Judge, Chengalpet. The learned counsel therefore requested that the Court below can be directed to accommodate the counsel on every Monday and Friday and the counsel undertook that she will be present before the Court on those days and will co-operate for the early disposal of the case.
