Petition filed under Article 226 of the Constitution of India, to issue a Writ of Habeas Corpus to call for the entire records relating to the petitioner's son detention under Tamil Nadu Act 14 of 1982 vide detention order dated 31.07.2019 on the file of the second respondent herein made in proceedings Memo C.No.62/G/IS/2019 quash the same as illegal and consequently direct the respondents herein to produce the petitioner's son namely N.Dheenathayalan @ Dheena, S/o.Nagaraj, aged 26 years before this Court and set the petitioner's son at liberty from detention now the petitioner's son detained at Central Prison, Coimbatore.

The petitioner challenges the impugned order of detention in C.No.62/G/IS/2019 dated 31.07.2019, detaining her son as "Goonda", as contemplated under Section 2(f) of the Tamil Nadu Act 14 of 1982.

The learned Additional Public Prosecutor reports that the order of detention passed against the detenu has been revoked by the Government by its order in G.O.Rt.No.3625 Home, Prohibition and Excise (XII) Department, dated 23.09.2019 and he has also produced a copy of the Government Order. Recording the same, this Habeas Corpus Petition stands closed.
