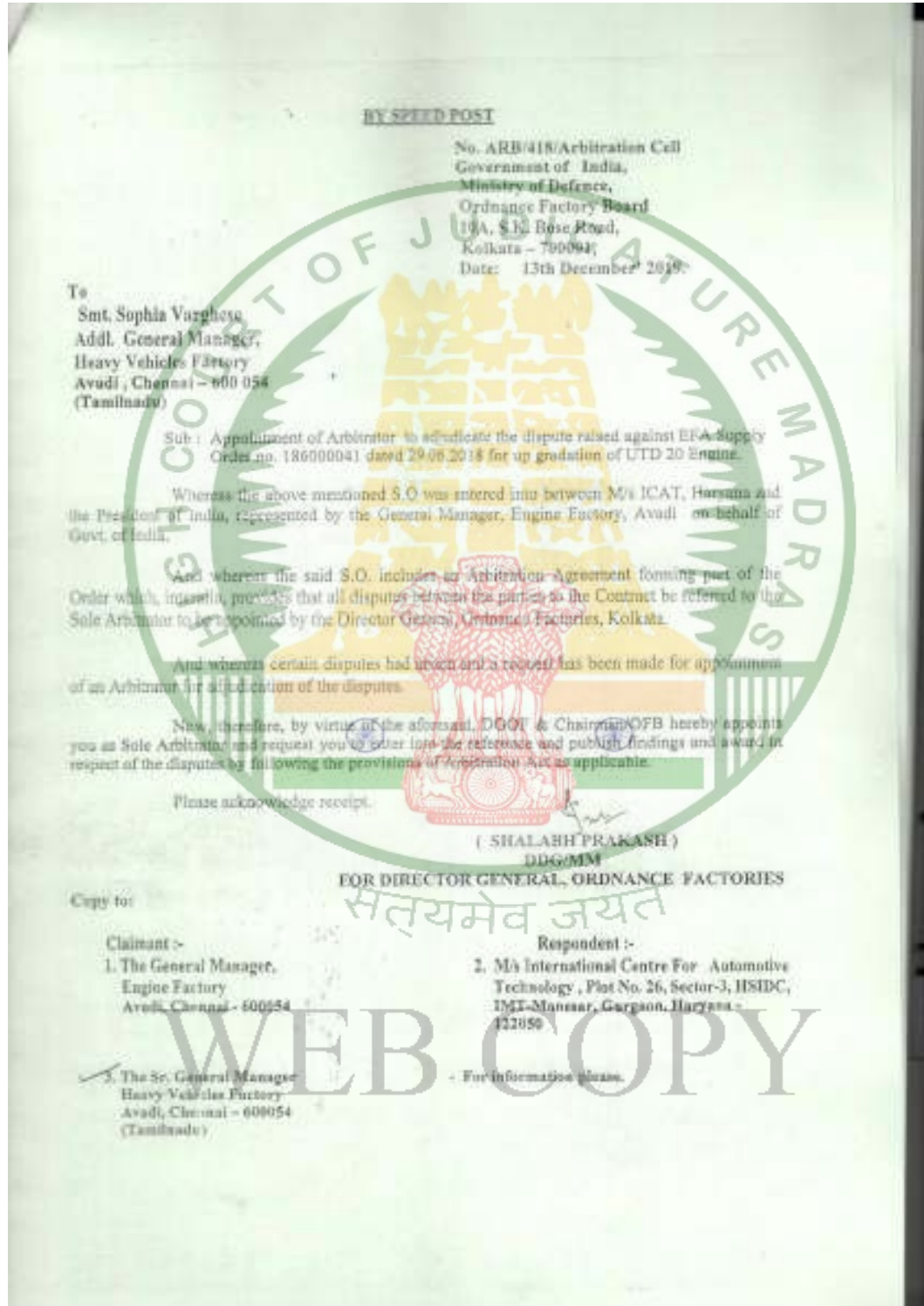

4. Both sides agreed on the above appointment and therefore, this O.P. is closed recording the aforesaid memo including order of appointment and there shall be no order as to costs.

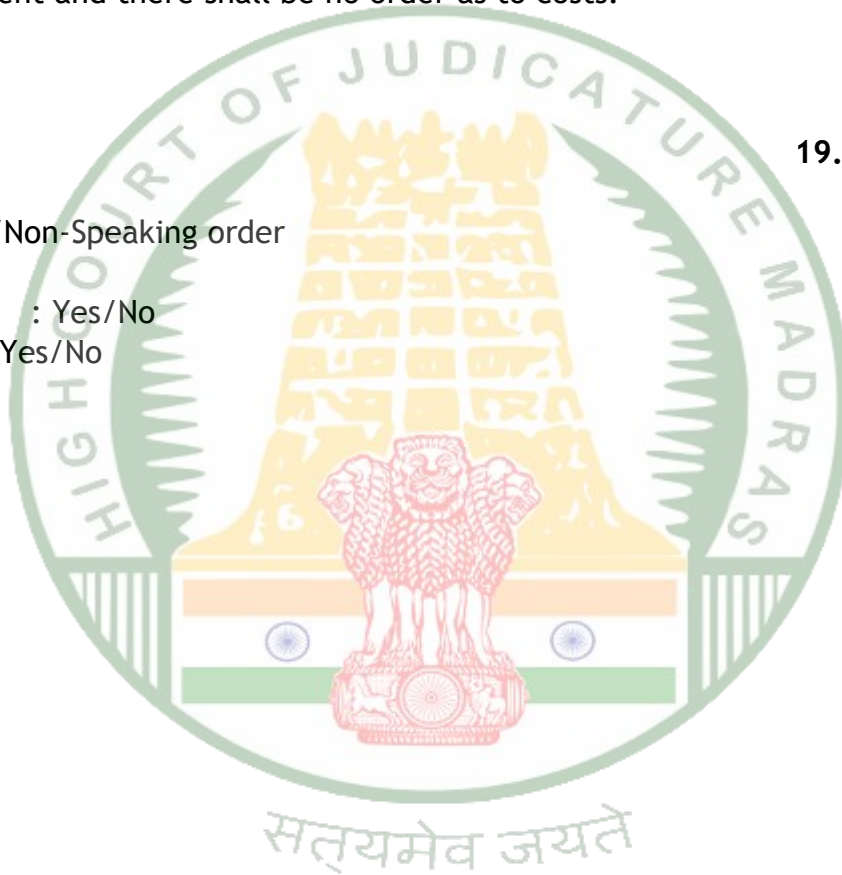
