O R D E R

This petition has been filed seeking a direction, to direct the learned Additional Sessions Judge, (PCR), Special Judge for Prevention of SC/ST Atrocities Act, Perambalur, Perambalur District, to consider the bail application to be filed by the petitioners in Crime No.133 of 2019 on the file of on the file of the Inspector of Police, V.Kalathur Police Station, Perambalur District, on the same day.

2.In view of the amendments made in the Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Act, 1989, this Court is of the view that the usual directions that were issued



by this Court cannot be issued routinely in all cases. Therefore, the petitioner is directed to surrender before the trial Court within a period of two weeks from the date of receipt of a copy of this order and on such surrender, learned Additional Sessions Judge, (PCR), Special Judge for Prevention of SC/ST Atrocities Act, Perambalur, Perambalur District, shall deal with the matter on the same day on merits and in accordance with law, after issuing notice to the victims under Section 15 (A) of the SC/ST Act.

3. This Criminal Original Petition is disposed of with the above directions.
