The learned counsel for the petitioner has submitted that as per the order of this Court, the petitioner went to deposit the demand draft for a sum of Rs.3.25 lakhs before the learned V Metropolitan Magistrate, Egmore, on 11.12.2019, but the learned Metropolitan Magistrate, has returned the said demand draft stating that this Court has not directed the petitioner to deposit the said demand draft.

It is seen from the order of this Court dated 11.12.2019, that this Court has directed the petitioner to deposit the amount of Rs.3.25 lakhs before the V Metropolitan Magistrate to the credit of C.C.No.5604 of 2019 but he has not been permitted to deposit the demand draft. The petitioner has not complied with the orders of this Court. Hence, this Criminal Miscellaneous Petition is dismissed.
