2. Heard the submissions made by the learned counsel for the petitioners.

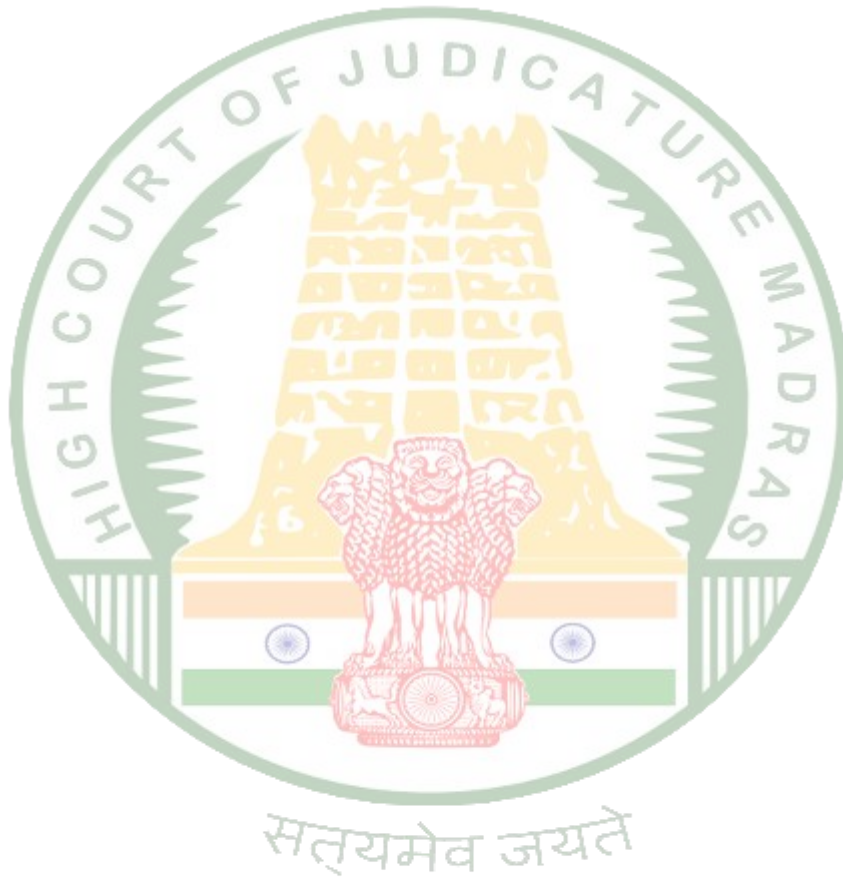
