Sriram, Learned Counsel for the Third Respondent and Mr. M. Kalyanasundaram, Learned Senior Counsel assisted by Mr. S. Ponjeganathan, Learned Counsel appearing for the Fourth and Fifth Respondents and perused the materials placed on record, apart from the pleadings of the parties.

The Writ Petition has been filed for a direction to the First to Third Respondents to consider the representation dated 19.08.2019 made by the Petitioner and consequently direct the Third Respondent to take necessary action against the Fourth and Fifth Respondents for collecting fraudulent funds in the name of 'Thiruppani, Annadhanam, Koil Thiruvizha and New Temple Construction' for Sri Sarvasakthi Mariyamman Temple, M.M.D.A Mathur, Mathavaram, Chennai - 600068.
