2. The learned counsel appearing for the first defendant filed an affidavit stating in paragraph No.3 which reads as follows:-

"I undertake not to alienate or encumber the property which is subject matter of the Application No.105/2017 in C.S.No.12/2017, without permission of this Hon'ble Court. In fact the property was granted for 99 years lease by SIPCOT and it is also equitable secured by Deposit of Title Deeds with Central Bank of India, Teynampet Branch, Chennai."

3. In view of the undertaking provided by the first defendant and recording the same, the application is closed.

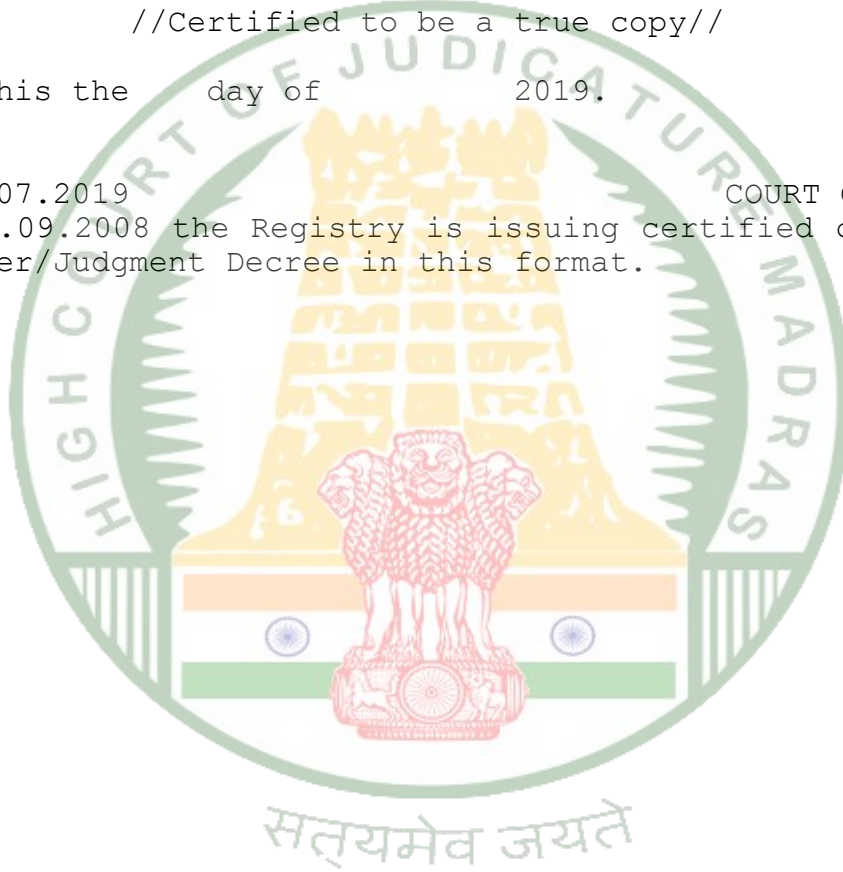
