2 The learned counsel for the petitioner would submit that this Court, in its order dated 05.01.2019 had suspended the sentence imposed on the petitioner till 05.01.2017 with a direction to report before the Judicial Magistrate, Additional Mahila Court, Salem at 10.30 a.m., on the first working day of every English Calendar Month pending appeal and would seek modification that the condition of appearing before the Trial Court on the first working day of every month, be modified.

5 Taking into consideration the submission made by the learned counsel for the petitioner, the condition imposed vide order dated 05.01.2017 is hereby modified and the petitioner shall appear before the Trial Court once in three months commencing from the first working day of October 2019, pending revision.
