No.217 School Education [Pa.Ka.5(1)] Department dated 20.06.2019 and the subsequent impugned order issued by the third respondent in Na.Ka.No.2687/E2.E3/2019 dated 30.08.2019 and to quash the same in so far as the clause in Para 4(I)(ii) is concerned and consequently directing the respondents to allow the petitioner to continue to work as Secondary Grade Teacher in Pallipet Block, Thiruvallur District.

3. Heard the learned counsel for the petitioner and the learned Government Advocate appearing for the respondents and perused the entire materials on record.

4. In view of the above submission, nothing survives in this Writ Petition and however, this Court directs the petitioner to join the Panchayat Union Middle School, Sreenivasapuram, Tiruttani Block, Thiruvallur District on or before 02.12.2019.

5. In the result, the Writ Petition is closed. No costs. Consequently connected Miscellaneous Petitions are closed.
