The instant writ petition has been filed for a mandamus directing the respondents 1 to 4 to permit the general public and students of the Karuvalur Village Panchayat to use as a full time public library in Plot No.24, Samidevar Nagar, Karuvalur Village, Avinashi Taluk, Tiruppur District till a permanent library is constructed at Karuvalur Village Panchayat.

On this day, when the matter came up for hearing, Mr.K.Selvaraj, learned counsel for the petitioner submitted that building in Plot No.24, Samidevar Nagar, Karuvalur Village, Avinashi Taluk, Tiruppur District is maintained by Karuvalur Village Panchayat, represented by Special Officer/Block Development Officer, Avinashi taluk, Tiruppur district/third respondent. He further submitted that the District Collector, Tiruppur district/ first respondent has ordered for use of the said building, as a permanent library.

3. Placing on record the submissions of the learned counsel for the petitioner, nothing survives in this writ petition for issuance of mandamus. Accordingly the writ petition stands disposed of. No costs. Consequently connected miscellaneous petition is also closed.
