O R D E R

[Order of the court made by M.M.SUNDRESH,J.]

The Petitioner, who is the mother of the detenu, has come up with this Petition, seeking production of the detenu.

2. The detenu, the Petitioner and her husband are present before us. Very recently, the detenu has attained majority. The detenu has got some reservations in rejoining her parents. The Petitioner and her husband are also agreeable to the detenu's wish to continue her studies in D.K.M. College for Women, Vellore. The said College also has Hostel facility.

3. Considering the above, we direct the Principal, D.K.M. College for Women, Vellore to conduct special classes for the detenu to cover up the deficiency in attendance, if any. The College authorities shall also consider providing Hostel accommodation to the detenu.

4. The statement made by the Petitioner and her husband that they will not force the detenu in getting married till her completion of studies, is recorded. The detenu is set at liberty.

5. This Habeas Corpus Petition is closed with the above direction.

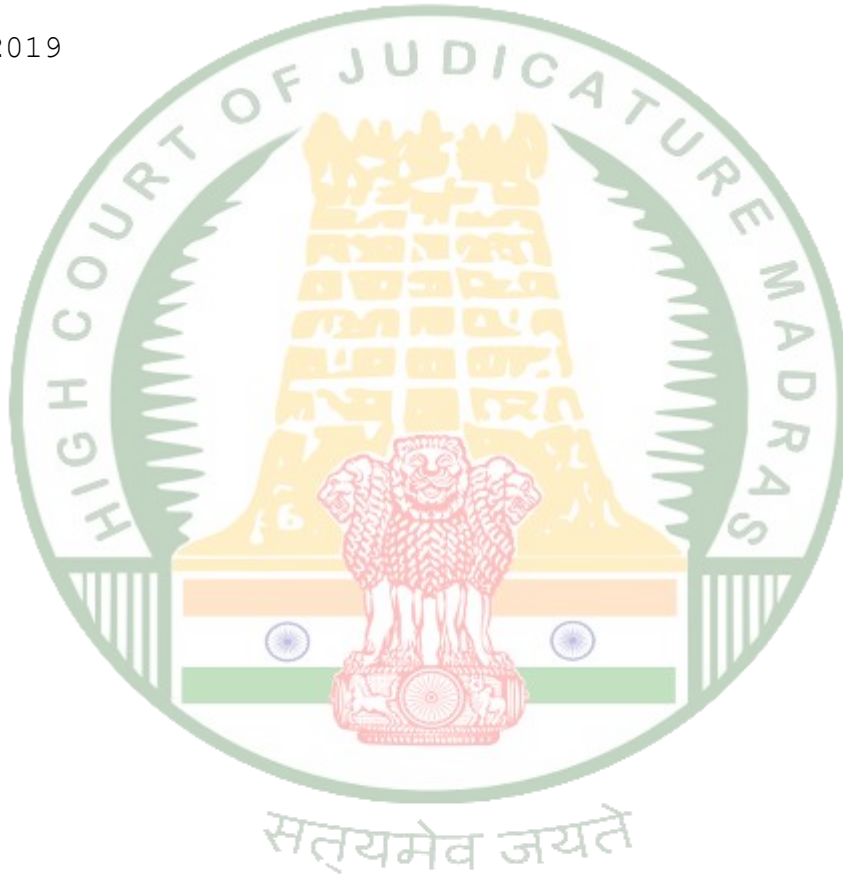
