J U D G M E N T

(Judgment of the Court was delivered by K.K. SASIDHARAN,J.)

The writ petition in W.P. No. 20127 of 2013 filed by the appellant challenging the order denying her promotion was dismissed by the learned Single Judge by order dated 21 November, 2016. Feeling aggrieved, the appellant has come up with this intra-court appeal.

2. When this appeal came up for hearing before us on an earlier occasion, we directed the respondents to consider the case of the appellant sympathetically and grant her promotion. Accordingly, the Tamil Nadu Tourism Development Corporation has passed an order dated 28 March, 2019 promoting the appellant from the post of Telephone Operator to the post of Store Keeper.

3. The learned counsel for the appellant contended that the appellant was not given her due promotion.

4. In view of the order dated 28 March, 2019, we are of the view that there is no need to keep this appeal pending.

5. It is always open to the appellant to approach the appropriate forum, in case, she is still aggrieved.

6. The writ appeal is disposed of with the above observation. No costs. Connected C.M.P is closed.

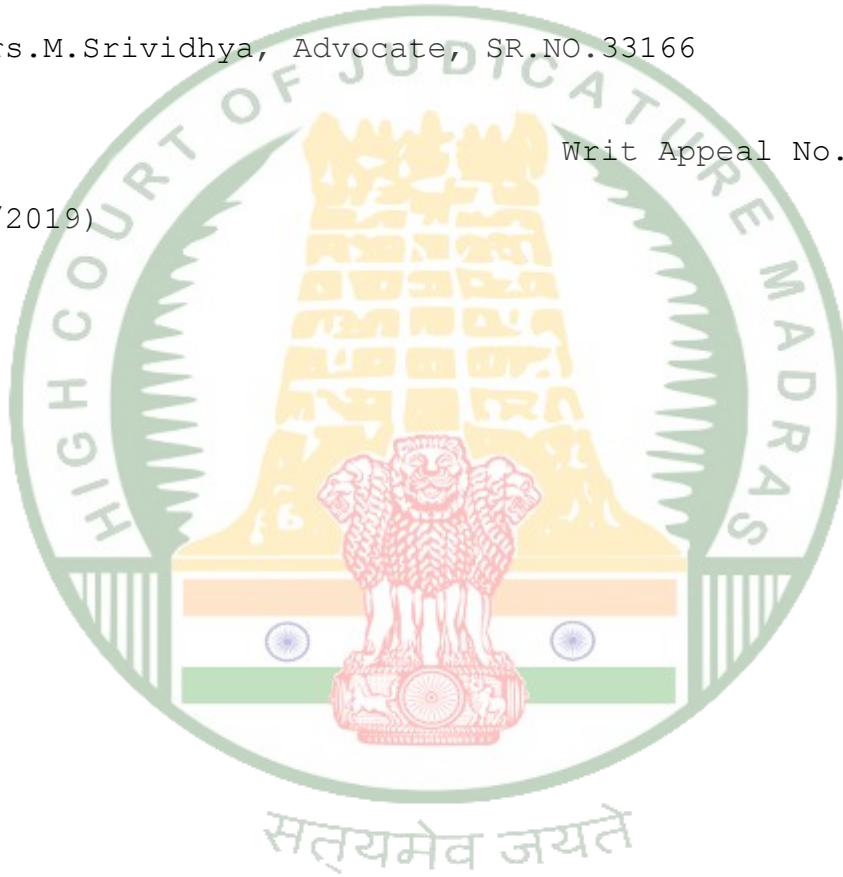
