J U D G M E N T

(Judgment of the Court was delivered by N.KIRUBAKARAN, J)

The Writ Appeal has been filed against the order passed in W.P.No.11189 of 2010 dated 12.07.2019 on the file of this Court.

2.The learned counsel appearing on behalf of the appellant would submit that the learned single Judge has observed as if the learned counsel appearing on behalf of the petitioner admitted to pay the amount, whereas no specific admission was made by the petitioner before the learned single Judge.
