Since there was no progress in the investigation and none of the accused persons was secured and the stolen articles were not recovered, the present petition has been filed seeking for transfer of investigation.

Taking into consideration the facts and circumstances of the case, there shall be a direction to the Assistant Commissioner of Police, Ashok Nagar, Chennai to monitor the investigation conducted by the 4th respondent. The 4th respondent shall effectively carry on with the investigation and file a final report after securing the accused persons and recovering the stolen articles, as expeditiously as possible.

4. This Criminal Original Petition is disposed of with the above directions.
