2. Heard the learned counsel for the petitioner. Despite serving notice on the respondent and his name printed in the cause list, there is no appearance on behalf of him.

3. The learned counsel for the petitioner submitted that due to financial constrains, the petitioner was not able to comply with the second condition of the earlier order of this Court, dated 30.08.2019, namely, to deposit Rs.1,00,000/- before the Trial Court within four weeks of the petitioner's release.

4. Acceding to the said request, a time of three weeks from the date of receipt of a copy of this order, is granted to deposit such amount. This Crl.M.P. is ordered accordingly.
