O R D E R

The petitioners, who have been arrayed as accused, were granted bail by the learned Principal District and Sessions Judge, Thiruvallur on 07.09.2019, on certain conditions. Seeking to modify the same, the present petition had been filed.

2. The learned Government Advocate (Crl. Side) appearing for the respondent submitted that the petitioners are complying with the condition imposed by the learned Principal District and Sessions Judge by reporting before the Ponneri Police Station regularly.

3. Taking into consideration the submission made by the learned Government Advocate (Crl. Side), this Court is of the view that if the petitioners are directed to be present before the respondent herein, the ends of justice could be secured.

4. In the light of the above observations, the condition imposed in the earlier order dated 07.09.2019 passed in Crl.M.P.No.4403 of 2019, directing the petitioners to report daily before Ponneri Police Station, is relaxed and the petitioner shall report before the respondent herein, as and when required.

5. All other observations made in the earlier order dated 07.09.2019 shall remain intact.

6. The Criminal Original Petition stands ordered accordingly.
