2.Recording the endorsement, this application is dismissed as withdrawn.

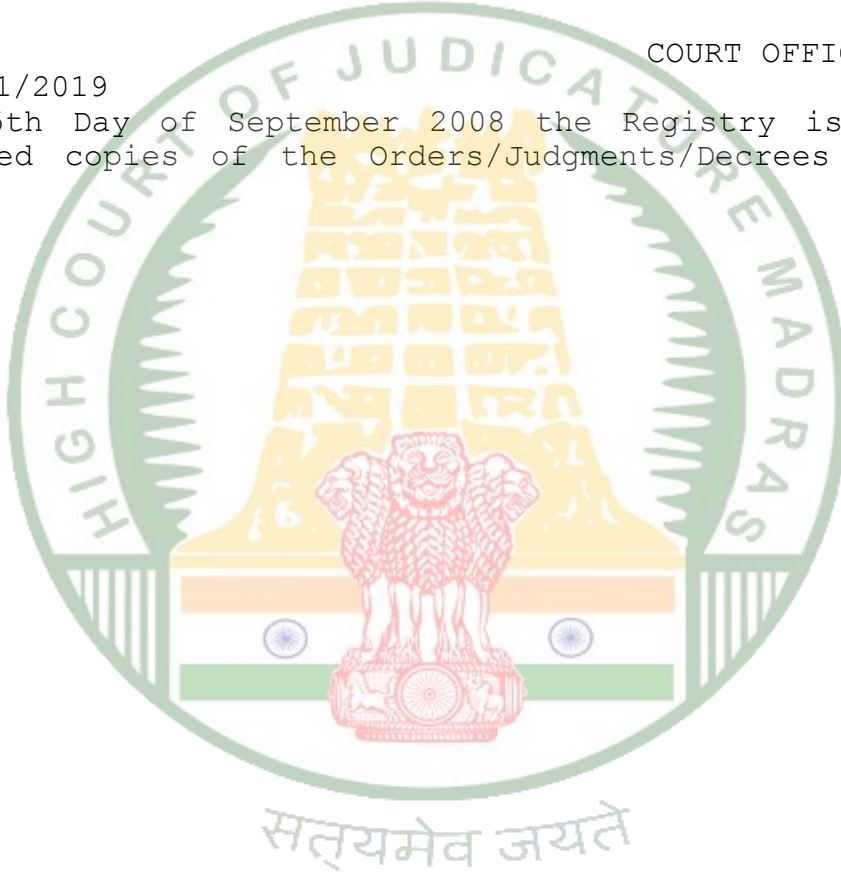
