O R D E R

This petition is filed for a direction to the Principal Sessions Judge, Salem (The Special Judge for SC/ST Act cases) Salem, to consider the bail application of the petitioner on the same day in Crime No.282 of 2019 on the file of the respondent, since the offences are pertaining to the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989.

In view of the specific bar under Section 18 of the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989 and also taking into consideration of the possibility of misusing the pious intention of the Parliament against innocent persons, there shall be a direction to the Principal Sessions Judge, Salem (The Special Judge for SC/ST Act cases) Salem, to consider the petitioners'



bail application, preferably on the same day of his surrender in connection with Crime No.282 of 2019 and pass appropriate orders in accordance with law, after affording due opportunity to the victim. The petitioners' shall surrender before the concerned jurisdictional Court, within a period of fifteen (15) days from the date of receipt of a copy of this order.

3. In view of the above, the Criminal Original Petition stands ordered.
