ORDER

This petition has been filed seeking to direct the respondent police to alter the FIR and to add Sections 307 and 506(ii) along with 448, 341, 323 IPC in Crime No.947 of 2017 pending on the file of the 4<sup>th</sup> respondent.

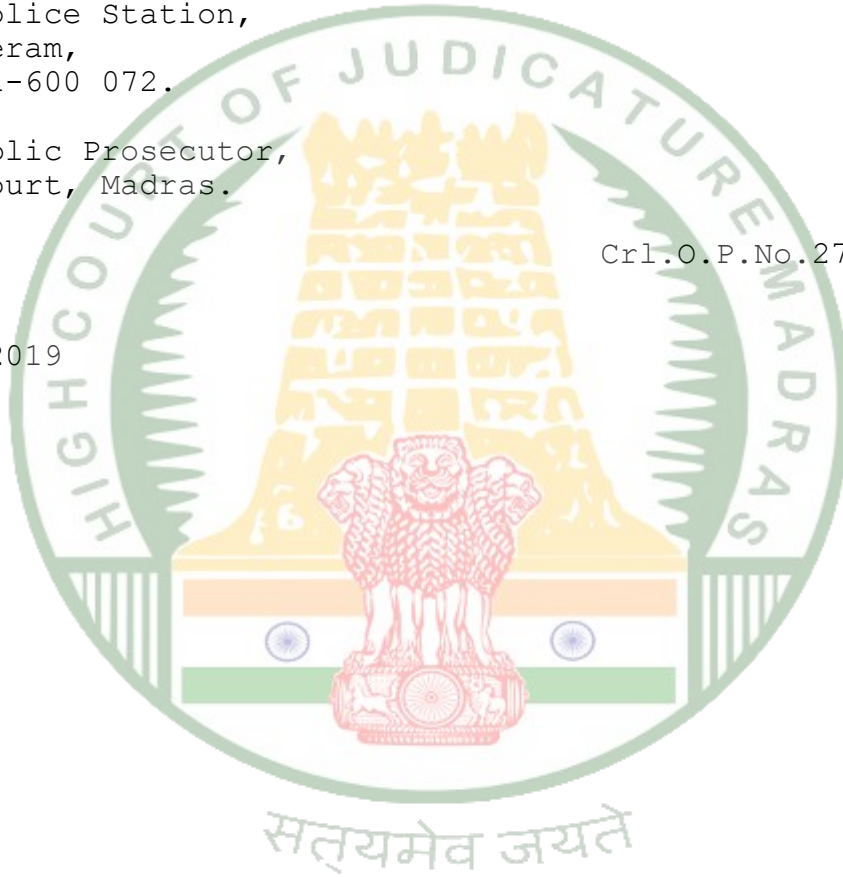
