Writ Petition filed under Article 226 of the Constitution of India seeking to issue a writ of Mandamus, directing Respondent to consider the Petitioner's representation given on 20.09.2019 for grant of Vending Licence to run the Bunk Shop in Lattice Bridge Road, near Indira Nagar, 4th Avenue, Thiruvannamiyur, (Opposite to IMPCOPS), Chennai, as per the provisions of the Street Vendors (Protection of Livelihood Regulation) Act, 2014 and further direct the Respondent or anybody under the Authority of the Respondent from interfering with the running of the Petitioner's Bunk Shop, pending disposal of the above representation.

The Petitioner seeks a direction to the Respondent to consider his representation dated 20.09.2019.

2. Learned counsel appearing for the Respondent/Corporation submitted that, no Self-Employment Scheme for Differently-abled People is in existence.

3. We are not inclined to go into such issue, as the prayer is only to consider the Petitioner's representation.

4. The prayer for grant of Vending licence to run the Bunk Shop, cannot be gone into by us, as it is a disputed question of fact. Therefore, we refrain from passing any positive order in this matter.

5. We merely direct the Respondent/Corporation to consider the Petitioner's representation dated 20.09.2019, within a period of four weeks from the date of receipt of a copy of this order.

6. The Petitioner is directed to send a copy of the representation dated 20.09.2019 to the Respondent/Corporation, within a period of one week from the date of receipt of a copy of this order.

This Writ Petition is disposed of with the above direction. No costs.
