2. According to the Petitioner, it would be difficult for her to travel all the way from Nagercoil, Kanniyakumari District to attend the hearings in I.D.O.P.No.100 of 2019 pending on the file of Principal District and Sessions Court, Coimbatore.

3. Heard the learned counsel for the parties. Learned counsel appearing for the Respondent submitted that, the Respondent has no objection to transfer the proceedings in I.D.O.P.No.100 of 2019 from the file of the Principal District and Sessions Court, Coimbatore to the file of the Principal District Court, Nagercoil.

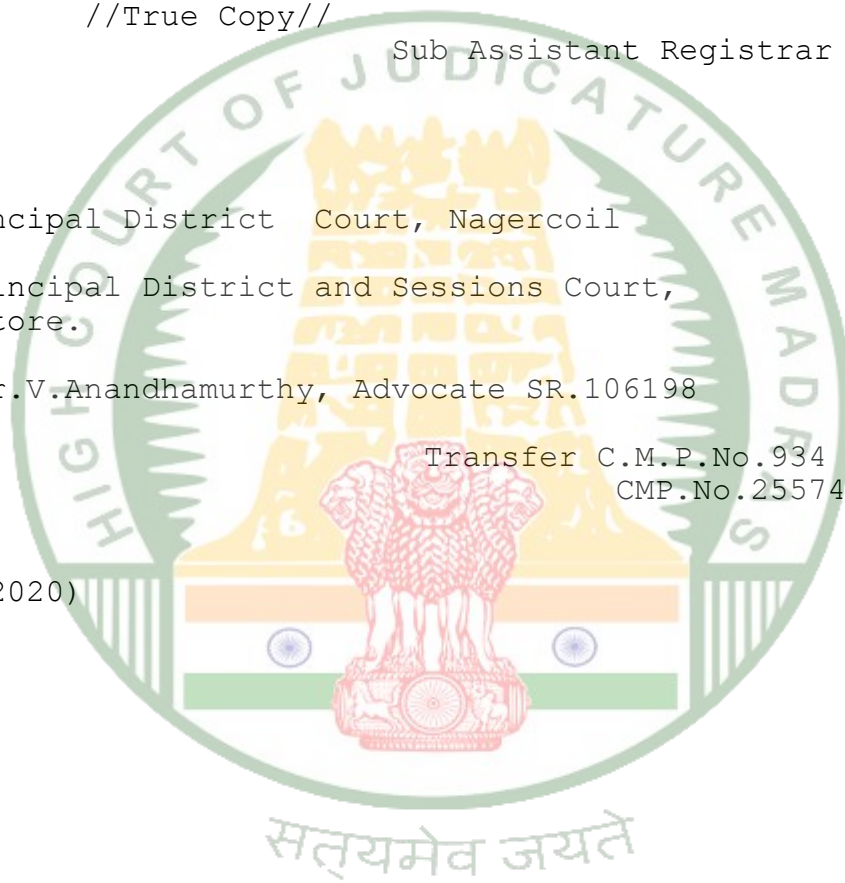
