ORDER

Though the prayer made in the writ petition is for a larger relief, the learned counsel for the petitioner confined the prayer to the limited extent of disposal of the representation dated 12.04.2017 filed by the petitioner before the third respondent, viz. Additional Assistant Elementary Educational Officer, Tiruvallur District.

2. Mr. P. Raja, learned Government Advocate appearing for the official respondents 1 to 3 states that the representation which was originally returned with some queries has been re-presented by the petitioner and is pending disposal before the third respondent.

In the aforesaid circumstances, it would suffice that a direction be issued to the third respondent to consider and also pass appropriate orders on the representation of the petitioner dated 12.04.2017, after hearing the petitioner, in accordance with law, within a period of four weeks from the date of receipt of a copy of this order.

4. The writ petition is disposed of accordingly. No costs. Consequently, the connected miscellaneous petition is closed.
