2. Today, J.Anandan, Inspector of Police, Arcot Town Police Station and G.Seetha, Sub-Inspector of Police, Arcot Town Police Station, are present before this Court.

3. On 29.11.2019, this Court passed the following order:

4. As directed by this Court in the aforesaid order, Pravesh Kumar, I.P.S., Superintendent of Police, Vellore, was present on 18.12.2019, but, there was no sitting of this Court and therefore, he marked his presence before the Joint Registrar (Original Side) of this Court.

5. On instructions, the learned Government Advocate (Crl.Side) submitted that the investigation in Crime No.597 of 2017 was completed and the final report has been taken on file as C.C.No.130 of 2019 by the Judicial Magistrate Court

and 506 (II) IPC and Section 4 of the Tamil Nadu Prohibition of Harassment of Women Act, 1998. She also submitted that the investigation in the counter case in Crime No.131 of 2019 was also completed and the final report has been taken on file as C.C.No.131 of 2019 by the Judicial Magistrate Court No.I, Arcot, for the offences under Sections 294-B, 324 and 506 (II) IPC.
