C O M M O N O R D E R

These Criminal Original Petitions have been filed to grant a general direction directing the 2nd respondent to file a report pertaining to the detention of the deteneu by names Sony Sharma, Bakiya Lakshmi, Pavithra, Suganya and Latha and in pursuance direct the IV Metropolitan at Saidapet, Chennai, to dispose the CrI.MP.Nos. Not known, 431, 432, 433 and 434 of 2019 in Cr.Nos.63 and 66 of 2019 on the file of 1st respondent as expeditiously.

2. The learned counsel for the petitioners has submitted that on 21.11.2019, the first respondent police registered a case against the employer of the victim girls in Cr.Nos.63 and 66 of 2019 under Sections 3(2)(a), 4(1), 5(1)(a) of Immoral Traffic Prevention Act and produced before the IV Metropolitan Magistrate at Saidapet, Chennai and sent to the custody of the third respondent Home. He further submitted that the victim



girls are the petitioners' daughter and they were not involved in any immoral activities. He further submitted that the petitioners have filed CrI.MP.Nos.Not known, 431, 432, 433 and 434 of 2019 before the IV Metropolitan at Saidapet, Chennai, to release their daughters and the same are pending for P.O report and hence, they prayed to direct the second respondent to file a report immediately and also direct the IV Metropolitan Magistrate at Saidapet, Chennai, to dispose of the CrI.MP.Nos.Not known, 431, 432, 433 and 434 of 2019 in Cr.Nos.63 and 66 of 2019 as expeditiously.

3. Considerng the aforesaid submission, the second respondent is directed to file a report within a period of five days from the date of receipt of a copy of this order and thereafter the learned IV Metropolitan Magistrate at Saidapet, Chennai, has to dispose of the petitions within two days.

4. With the above observations, these petitions are disposed of. Consequently, connected miscellaneous petitions are closed.
