4 Taking into consideration and the said submission, the condition is modified to appear before the Committal Court viz., XVIII Metropolitan Magistrate, Saidapet, Chennai once in three months, on the first working day of the concerned month at 10.30 a.m., starting from the month of January 2020, until further orders.
