Principal District and Sessions Court, Coimbatore is modified to the effect that the petitioners are ordered to be enlarged on bail on their executing a bond for Rs.1,00,000/- with two solvent sureties. All other observations made in the earlier order dated 30.10.2019 shall remain intact.
