Haja Mohideen Gisthi, Learned Counsel appearing for the Respondents, on instructions, states that the Second Respondent by letter dated 20.11.2019 informed the Fourth Respondent that it would not be appropriate to conduct election in the manner that would be contrary to the scheme rules framed by the Sub-Court, Salem in O.S. No. 205 of 1953 and resultantly, the election scheduled in the meeting of the General Body proposed to be held on 22.11.2019 in respect of the Sulthan Jamia Pallivasal, Attur, Salem District, has been postponed and he has filed a memo to that effect.

3.. Recording the aforesaid subsequent events, the Writ Petition is disposed. Consequently, the connected Miscellaneous Petitions are closed. No costs.
