Petitioner has sought for a writ of mandamus, directing the respondents to consider his representations dated 26.5.2017, 5.6.2017 and 23.6.2017 and to stop establishing the TASMAC shop at Thirumanan Thottam, Ettiverampalayam Village, Avanishi Taluk, Tiruppur District.

On instructions from the District Manager/Deputy Collector, TASMAC Ltd, Tiruppur/respondent No.3, Mr.B.Nedunchezhiyan, learned standing counsel for TASMAC Ltd, would submit that no shop is proposed to be located at Ettiveerampalayam Village in Avinashi Taluk, Tirupur District.
