The writ petition has been filed to direct the respondents 1 to 3 to take action against the respondents 4 to 10 and other workmen who are indulged in violence and committed serious offence based on the petitioner representation dated 07.07.2017.

2. It is seen that the petitioner has sought for a direction directing respondents 1 to 3 to take action against respondents 4 to 10. 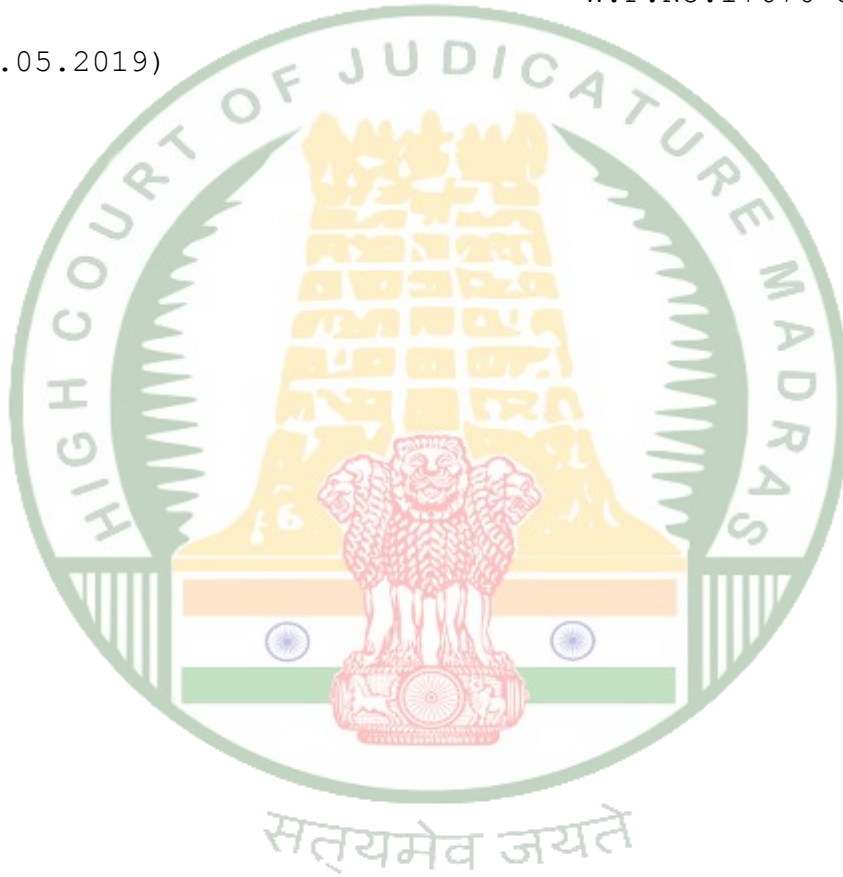
