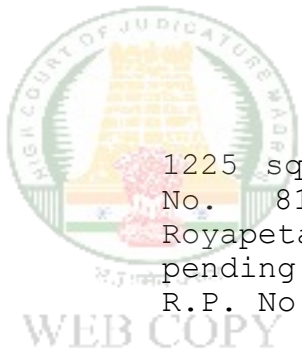

Sriram, Learned Counsel appearing on behalf of the Fourth Respondent and Mr. S.K. Rameshwar, Learned Counsel appearing on behalf of the Sixth Respondent and perused the materials placed on record, apart from the pleadings of the parties.

2. Learned Special Government Pleader (HR & CE) appearing for the First to Third and Fifth Respondents, on instructions, states that the Revision Petition filed by the Petitioner has been taken on file as R.P.
