Prayer : Writ Petition filed under Article 226 of the Constitution of India, praying to issue a Writ of Mandamus, directing the respondents 1 to 4 to pass appropriate orders in accordance with law by directing the respondents to change the place of vending stamps in respect of the 5th respondent to the place at No.19/32, Katta Gopuram Street, Tirukoilur, instead of No.57/81, Hospital Road, Tirukoilur, on the basis of the representation made by the petitioner on 09.06.2016.

ORDER

This Writ Petition is filed seeking for a direction to the respondents 1 to 4 to pass orders on the petitioner's representation dated 09.06.2016.

3. This Court, at this stage, is not expressing any view on the claim made by the petitioner as it is for the 3rd respondent to consider the claim of the petitioner and pass appropriate orders. Accordingly, this writ petition is disposed of by directing the 3rd respondent to consider the representation of the petitioner dated 09.06.2016 and pass orders on the same on merits and in accordance with law after giving due opportunity of hearing to the petitioner and the 5th respondent. Such exercise shall be done by the 3rd respondent within a period of six weeks from the date of receipt of a copy of this order. No costs.
