4. Since the matter is pending for nearly 6 months, it is hoped that the final orders would be passed on or before 31.01.2020. According the 1<sup>st</sup> respondent namely the Joint Commissioner of HR & CE Department, mayiladuthurai is directed to dispose of the case on or before 31.01.2020.

5. With the above observation, this writ petition is disposed of. No costs.
