3. The learned Additional Public Prosecutor has submitted that no complaint is received against the petitioner, but, the petitioner has lodged a complaint against some persons and only for enquiry purpose in that complaint, the petitioner was called and he was not subjected to any harassment.

4. If the petitioner lodged a complaint, he has to co-operate for enquiry. If he is called for enquiry with regard to his complaint, he cannot say that the said act is an harassment.

5. With the aforesaid observations, this petition is disposed of.
