2. 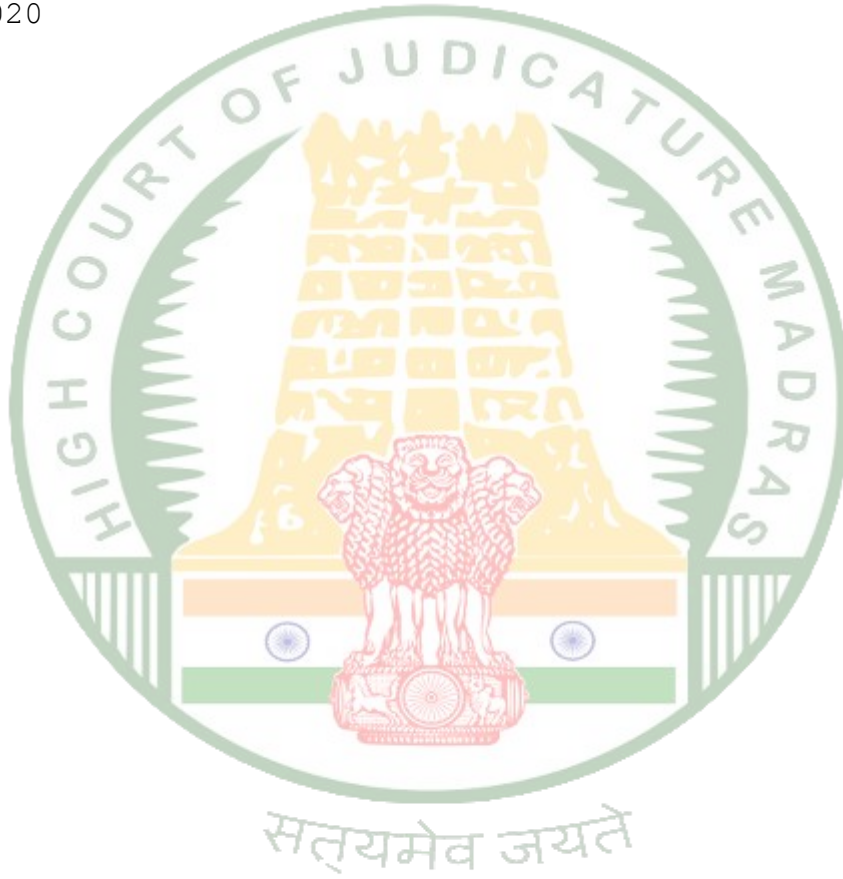
