- 2) We will lift the consignment immediately on receipt on intimation from TNTC Head Office/Warehouse, Erode and the delivery will be made promptly as per the instructions without fail.
- 3) We will deliver the consignment within 24 hours from the time of loading and in case there is any delay, the losses incurred will be recovered from us."
