Prayer in W.P.No.25585 of 2018: Writ Petition filed under Article 226 of the Constitution of India praying to issue a Writ of Mandamus, directing the respondents to take into account 50% of the service rendered by the petitioner from initial appointment till regularization (i.e., 01.09.1982 to 04.10.1996, 2.6.1986 TO 15.10.92, i.e., 25.7.84 to 31.3.90, i.e., 15.7.1987 to 15.10.1992, i.e., 8.8.1984 to 1.4.1990, i.e., 13.12.1989, to 21.2.1995, i.e., 11.11.1987 to 15.10.1992, i.e., 6.6.1986 to 15.10.92, i.e., 10.1.1983 to 15.10.1992, i.e., 10.12.1982 to 26.5.1992, i.e., 15.7.1987 to 15.10.92) for the purpose of retirement benefits, including pension.

COMMON ORDER

The relief as such sought for in these writ petitions is for a direction to direct the respondents to take into account 50% of the service rendered by the petitioners from initial appointment till regularization for the purpose of retirement benefits, including pension.

2. The learned Additional Government Pleader appearing on behalf of the respondents now brought to the notice of this Court that the claim set out in these present writ petitions were considered by the Government and an order was issued in G.O.Ms.No.194, School Education Department, dated 12.09.2018. As per the Government Orders, the 50% of the services are taken into account for the purpose of reckoning qualifying services for grant of pensionary benefits.

3. The Government considered the claim of the writ petitioners and passed an order redressing the grievances of the writ petitioners.

4. Thus, no further adjudication needs to be entertained in respect of the grounds raised in these writ petitions. It is made clear that the benefits granted in G.O.Ms.No.194, School Education Department, dated 12.09.2018 shall be extended to these writ petitioners, if they are otherwise qualified as per the conditions prescribed in the G.O.Ms.No.194.

5. With these directions, all these writ petitions stand disposed of. However, there shall be no order as to costs.

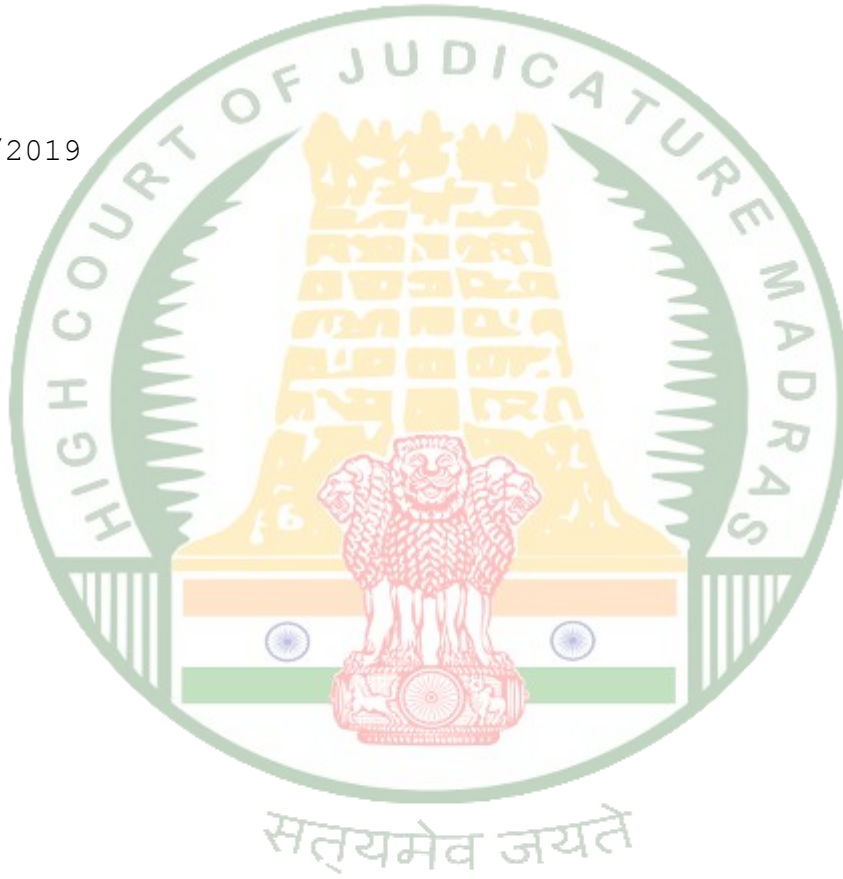
