The above Civil Revision Petition is filed challenging the order in EP.No.555 of 2018.

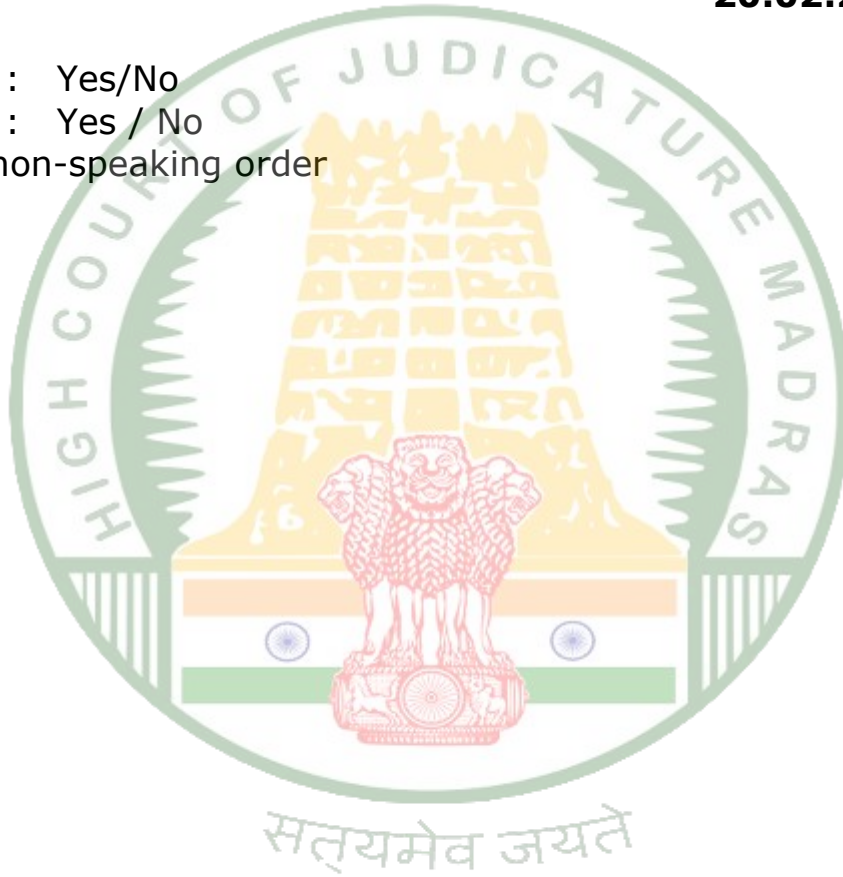

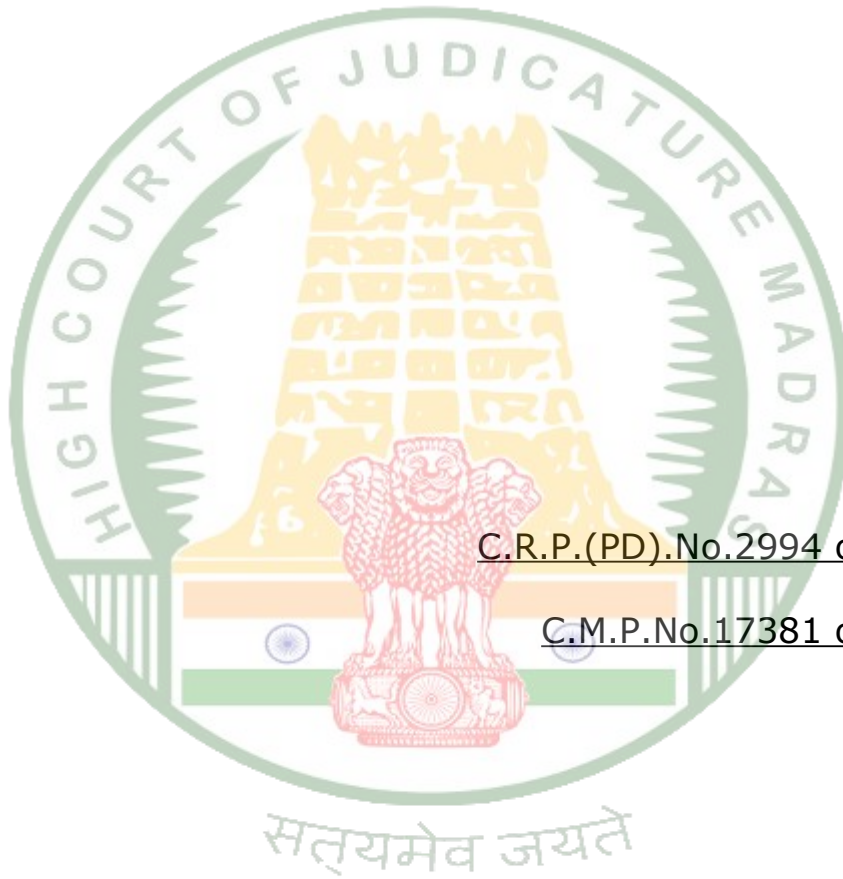

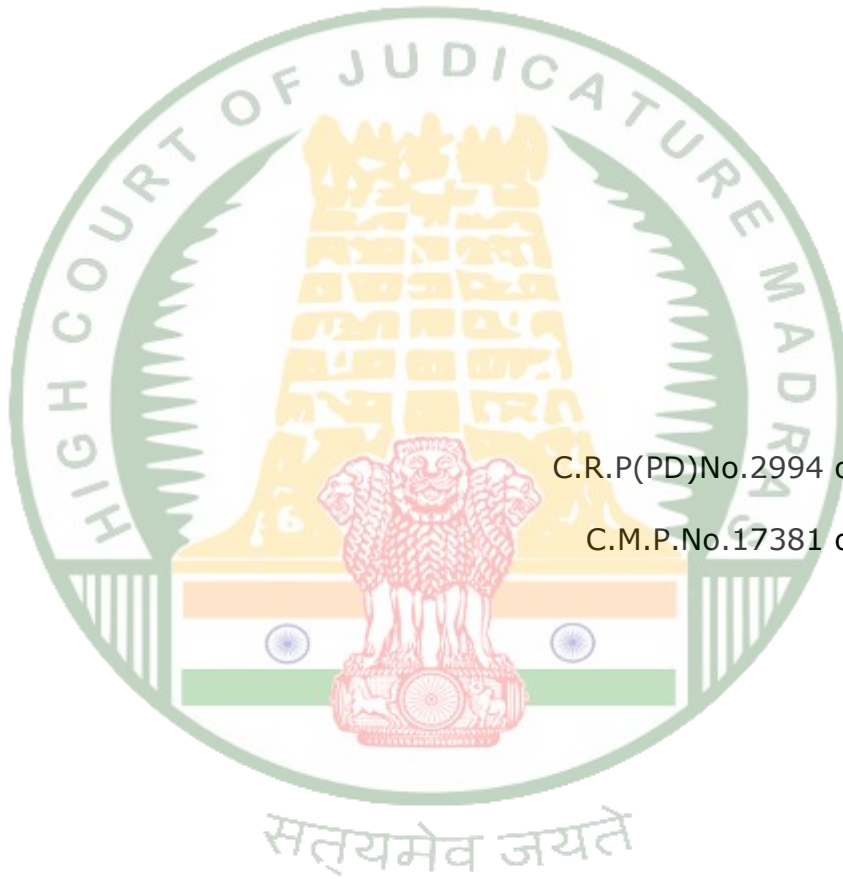
