PRAYER: Writ Petition is filed under Article 226 of the Constitution of India, praying for the issue of Writ of Certiorarified Mandamus, to call for the records and quash the Lr.No.ChePo/O & M/Va.Vaa/Thonu.u1/Ko.TAHDCO/No.144/2018-19 dated 21.08.2018 issued by the 1<sup>st</sup> respondent and consequently directing the 1<sup>st</sup> and 3<sup>rd</sup> respondent to pass orders allotting agriculture connection to the petitioner under the fast track supply scheme in Survey No.73/8B, Kandianallur Village, Nallur Post, Vandavasi Taluk, Tiruvannamalai-604 408.

The petitioner herein seeks service connection under the Fast Track Supply Scheme in Survey No.73/8B, Kandianallur Village, Nallur Post, Vandavasi Taluk, Tiruvannamalai-604 408.

2. According to the petitioner in spite of submitting all the necessary documents, no service connection has been given to him.

3. The learned Standing counsel appearing for the TANGEDCO would submit that the petitioner's application is old out dated and the documents has been furnished are of the year 2018. 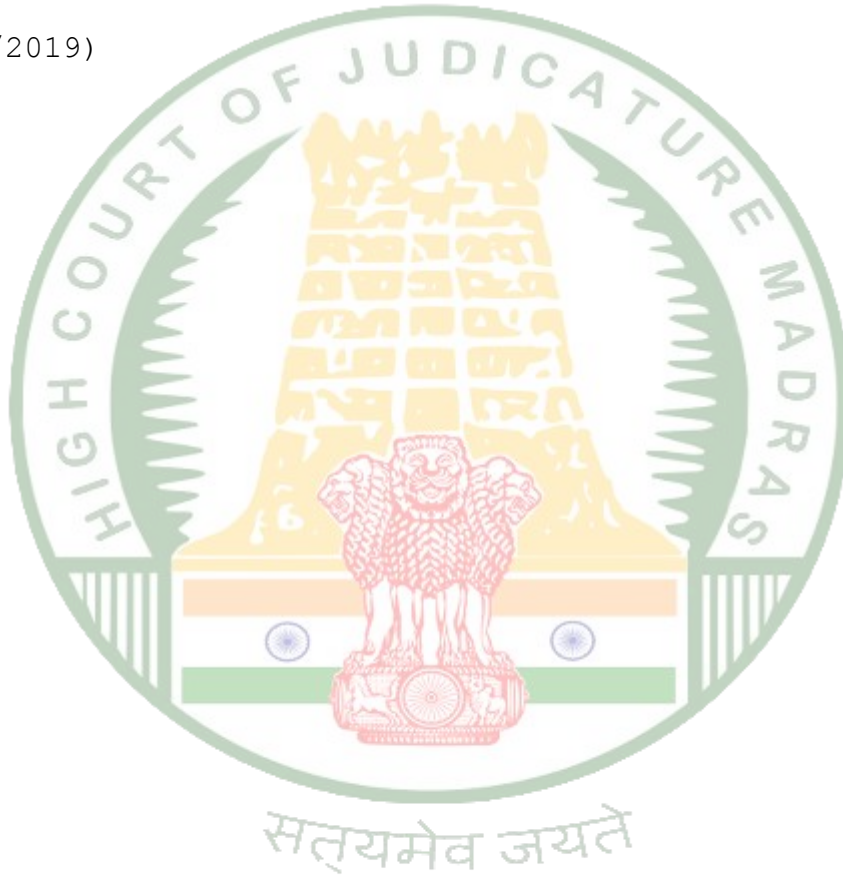
