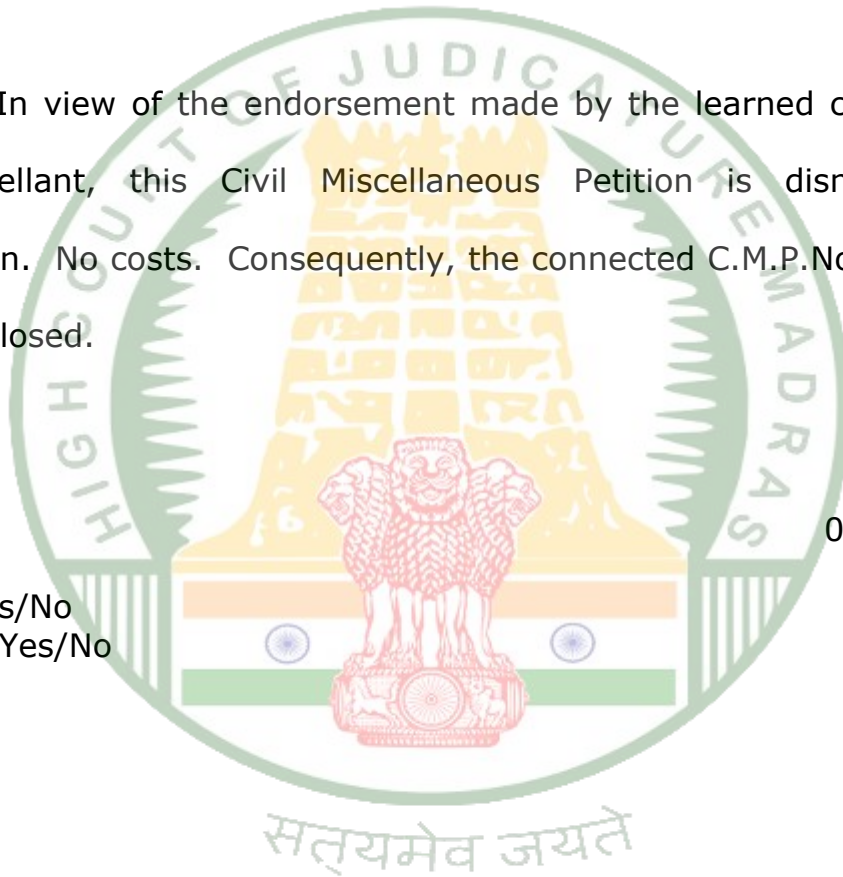
JUDGMENT

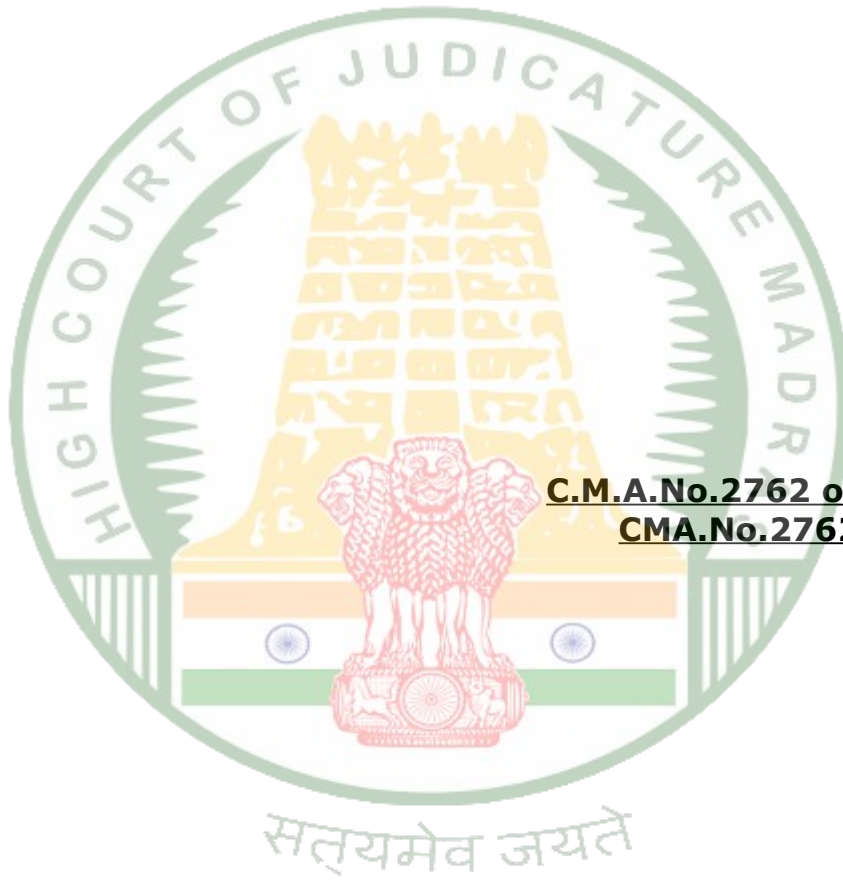
