PRAYER: Petition filed under Article 226 of the Constitution of India, to issue a Writ of Habeas Corpus, calling for the records relating to the Detention Order in C2/27153/2018, dated 20.09.2018 passed by the second respondent under the Tamil Nadu Act 14 of 1982 and set aside the same and direct the respondent to produce the petitioner's brother IMRANKHAN S/o. IBRAHIM aged about 25 years the detenu, now confined in Central Prison, Cuddalore before this Hon'ble Court and set the petitioner's brother IMRANKHAN S/o. IBRAHIM aged about 25 years the detenu herein at liberty.

ORDER

The petitioner, who is the sister of the detenu herein, viz., Imrankhan, son of Ibrahim, aged 25 years, has come forward with this petition challenging the detention order passed by the second respondent by his order in No.C2/27153/2018, dated 20.09.2018 against her brother branding him as a "GOONDA" under the Tamil Nadu Prevention of Dangerous Activities of Bootleggers, Drug Offenders, Forest Offenders, Goondas, Immoral Traffic Offenders, Sand Offenders, Slum Grabbers and Video Pirates Act, 1982 [Tamil Nadu Act 14 of 1982].

2. The learned Additional Public Prosecutor would submit that the order of detention passed by the second respondent as against the brother of the petitioner herein dated 20.09.2018 has been revoked by the Government in G.O.Rt.No.4929, Home, Prohibition & Excise [XIV] Department dated 07.11.2018 and he has also produced a copy of the said order.

3. Recording the submission of the learned Additional Public Prosecutor, this Habeas Corpus Petition is closed as the same has become infructuous.
