2.The learned Additional Public Prosecutor would submit that the order of detention passed by the second respondent as against the son of the petitioner herein dated 12.09.2018, has been revoked by the Government in G.O.Rt.No.4908, Home, Prohibition & Excise [XIII] Department dated 07.11.2018 and he has also produced a copy of the said order.

3.Recording the submission of the learned Additional Public Prosecutor, this petition is closed as the same has become infructuous.
