Prayer : Petition filed under Article 226 of the Constitution of India praying for issuance of a writ of habeas corpus calling for the records in connection with the order of detention passed by the 2nd respondent dated 20.09.2018 in No.864/BCDFGISSSV/2018 against the husband of the petitioner detenu Noorullah, M/A 27, son of Kadhar, who is confined at Central Prison, Puzhal, and to set aside the same and consequently, direct the respondents to produce the detenu before this Court and set him at liberty.

ORDER

(Order of the Court was made by M.SATHYANARAYANAN, J)

Petitioner, wife of the detenu herein, viz., Noorullah, son of Kadhar, aged about 27 years, has come forward with this petition challenging the detention order passed by the second respondent dated 20.09.2018 against her husband branding him as a "Goonda" under the provisions of the Tamil Nadu Prevention of Dangerous Activities of Bootleggers, Drug Offenders, Forest Offenders, Goondas, Immoral Traffic Offenders, Sand Offenders, Slum Grabbers and Video Pirates Act, 1982 [Tamil Nadu Act 14 of 1982].

2.The learned Additional Public Prosecutor would submit that the order of detention passed by the second respondent as against the husband of the petitioner herein dated 20.09.2018, has been revoked by the Government in G.O.Rt.No.4914, Home, Prohibition & Excise [XIII] Department dated 07.11.2018 and he has also produced a copy of the said order.

3.Recording the submission of the learned Additional Public Prosecutor, this petition is closed as the same has become infructuous.
