This Writ Petition has been filed seeking a direction to the third respondent to conduct enquiry under Section 81 of the Tamil Nadu Co-operative Societies Act, regarding the alleged misappropriation of funds from the fifth respondent-Society.

Today, Mr.Bala Ramesh, learned Standing Counsel appearing for the respondents, on instructions, submitted that an enquiry under Section 81 of the Tamil Nadu Co-operatives Societies Act has already been initiated by the third respondent. He has also produced a Xerox copy of the proceedings in Na.Ka.No.1787/2017/Pa.Tho. dated 03.12.2018 issued by the 3rd respondent whereby an Enquiry Officer was appointed to conduct the enquiry. 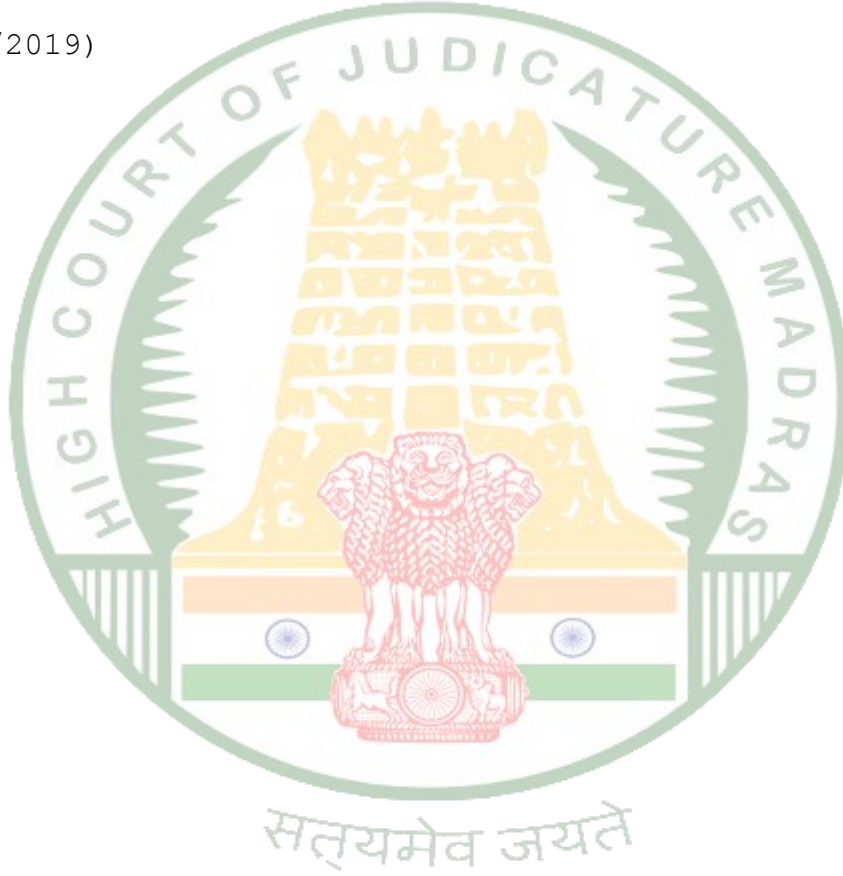
