Prayer : Petition filed under Article 226 of the Constitution of India praying for issuance of a Writ of Habeas Corpus to call for the entire records relating to the petitioner's son's detention under Tamil Nadu Act 14 of 1982 vide detention order dated 02.11.2018 on the file of the second respondent herein made in proceedings Memo Cr.M.P.No.24/Goonda/2018/C1, quash the same as illegal and consequently direct the respondents herein to produce the petitioner's son namely Senthil @ Senthil Kumar, S/o.Thangaraj, aged 31 years before this Court and set the petitioner's son at liberty from detention, now the petitioner's son detained at Central Prison, Coimbatore.

The said Government Order is produced before the Court and the same is taken on file.

2. In the light of the said development, nothing remains for further adjudication in this Habeas Corpus Petition and accordingly this petition is dismissed as infructuous.

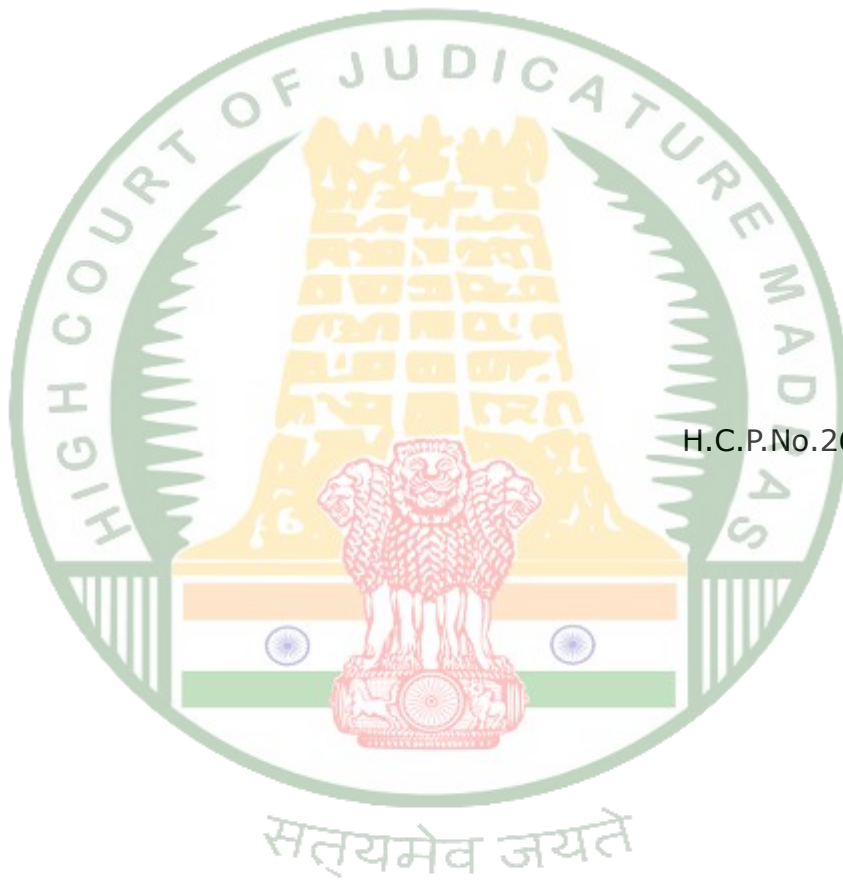
