Having regard to the facts and circumstances of the case, this miscellaneous petitions is allowed and the substantive sentence of imprisonment alone is suspended and the petitioner is released on bail on condition that the petitioner shall deposit a sum of Rs.10,000/- (Rupees ten thousand only) to the credit of S.C.No.248 of 2013 on the file of the learned VI Additional Sessions Judge, Chennai, and further the petitioner shall execute a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties each for a like sum to the satisfaction of the learned VI Additional

Sessions Judge, Chennai. Further, the petitioner shall appear before the trial Court on the first working day of every month at 10.30 a.m until further orders.
