This criminal revision case has been filed by the husband against the order dated 10.07.2018 in M.C.No.327 of 2017 granting maintenance of Rs.40,000/- per month by the learned III Additional Principal Judge, Full Additional Charge to II Additional Family Court, Chennai.

2 According to the learned counsel for the petitioner/husband, the arrears of maintenance works out to Rs.5,50,000/-.

3 There shall be an order of interim stay on condition that the petitioner/husband shall deposit 50% of the arrears of maintenance within a period of four weeks from the date of receipt of a copy of this order. In case, such deposit is not made within the stipulated time, the interim order shall stand vacated automatically with effect from the date of the order. The petitioner is directed to deposit the amount in the court account in reference to this Court.
